SCORPION CAVE FIELD TRIP--JULY 4-7, 1968 by Steve Knutson

PROPERTY OF SCORPION CAVE FIELD TRIP-JULI 4-7, 1900 by Steve Minuson WINDY OF 1. Location This information is presently restricted. Se Lee Rosenberg & GROTTO Cave Juction, Oregon. In general, the cave is located south of Oregon Care

2. History The cave was discovered by Lee Resemberg and companions in 1966. A fire-spotting pilot reported an obvious opening in a limestone culouse which Lee investigated and found to be a 50° cave (Lower C. ve.) Further investigation of the limestone outcrop resulted in the discovery of Scorpion CAve, the entrance of which was covered with rocks and from which issued a cool draft of air.

3. General Bearription The cave is quite complex in that it has at least four distinct levels and shows much evidence of vadose as well as phreatic solution. There is no running water at present, however, although small 50 pools exist on at least three of the levels. The Big Room area shows massive breakdown and breakdown exists at each end of the 4th level. Otherwise the cave is relatively intact. The formations are mainly flowstone with a deal of coralloid and areas covered with small aragonite crystals. Stalactites, stalagmites, and columns are not prominent. The most striking feature of the cave is the stream slot(s), up to 80° in vertical extent, which connect the 2nd, 3rd, and 4th levels at several points between the Cathedral room and the Big Room. Another feature of note is the presence of curtains of quartz produced when the limestone was dissolved away from quartz veins.

4. Mapping and Exploration Lee Rosenberg, et al., report the cave to be completely explored and that there exists about 2000' of passage. Cur mapping efforts produced about 500' (back of the Big Room to the Entrance) and I estimate that we visited another 600'; the resulting map indicating about 1100' of cave leaves many question marks. Doubtless Lee could explain most of these but certain ones should be checked carefully:

1) ¹he leads on the 2nd and 3rd levels which head south.

2) A slight draft was felt blowing out thru the 2' opening " leading to Windy Pit--if this pit merely leads to the 4th level, why the draft?

3) A strong draft was felt blowing out the pit just beyond the bottom of the Chute.

4) The pit adjacent to the entrance of the Big Room has been entered by one individual but not throughly checked.

5) All aspects of the 4th level.

The only mapping done so far is a baseline run from the back of the Big Room to the entrance and from the entrance to the various minor caves and sinks in the immediate vicinity.

5. Biology The only life observed was a bat and a salamander; I was so confused concerning cave passages at that time that I can't recall where they were. (Ed. Note: Also observed were: Spiders, similar to Black widows, and escaped before firm ident.) a scorpion which

For the year 1968 there were 40 recorded field trips, and many others that were not recorded. There were several organized trips, all of which were very successful.

Although every member of the grotto attended at least one trip, there was anly a small percentage that were on almost every trip.

Of the few organized projects started very few were completed.

Our relation with government agencies seems to have been maintained or even improved.

In the line of conservation very little was done.

Recommendations:

1. To promote activity within the grotto there should be at least one field trip a month.

2. There should be at least one organized and very well planned seasonal trip and a least two such trips should be carried out in the summer months.

3. The members of the grotto should try to complete all grotto projects/

4. Much more should be done in the line of conservation.

5. Activities such as dinners and slide shows should be encouraged as long as they are well planned.

CONMITTEE IN CHARGE OF GATING THE CAVES ON CAVE RIDGE

As most of you know, the caves on Cave Ridge are on private property. Soon there will be built an Alpental Roundhouse and Restaurant on Cave Kidge. We have, thanks to Dr. Halliday and the considerate owners, an agreement to allow us to use the caves IF we protect others from the caves. Terms of our lease state that we will place signs and provide gates on the caves.

This year, after two years of thought, we did indeed make progress. We now have signs in place at the five large caves: Cascade, Danger, Hellhole, Lookout, and Newton. Placement of the signs was designed so as not to attract the casual passerby, but to warn all who would risk entering without proper equipment or experience.

The signs were photocopied and prepared by Charles Anderson and mounted on site by Jack Hess and Bill Decker (of the Nittany Grotto). There is a large supply of extra signs to replace those lost to people, weather, and/or animals. If you disagree with the placement of these signs, do not take it upon yourself to change the sign. Tell your committee; that's what we're for.

This year we also made progress on gating our two most dangerous of use. Hellhole and Newton. he large entrance at Newton was narrowed to one offic chainable channel by Rick Rigg and Arch Olsen. A brush gate used to block the channel did not last long. A chain and lock will now be installed and the key will be kept by the Cascade Grotto.

Hellhole received attention from Bob Brown and friends who constructs ed a large log triangle over the sinkhole. A gate was to be built on these logs, but because of its size and non-obsurability, the idea was abandoned. Now a simple chain grid with lock and key is planned for installation next spring.

Fortunately the snow falls fast on Cave Ridge. By now entrances, sinks, valleys and hills are obscured by snow and no one will fall or crawl or dig their way into the caves. But it is only a temporary reprieve. Next spring we must finish the gates at Hellhole and Newton, and we must devise, build, and install gates on our other caves. If you are interested in caving on Cave Ridge, come volunteer your help.

3. Nominations will be made by a nominating committe, and submitted to the Nov. general meeting. Additional Nominations may be made from the floor at this meeting.

4. Campaign speechs will be strictly limited to two minutes per candiate and a timekeeper will be appointed to strictly enforce this rule.
